- Racing Rules:** The championship will be governed by the rules as defined in the Racing Rules of Sailing 2009-2012 ISAF incl. supplementary regulations of Swiss Sailing, class rules, Sailing Instructions issued by SCAe, Swiss Sailing regulation for the organization of Swiss Championships, Federal law of inland navigation and its local amendments. If there is a conflict between languages the German text will prevail
Sailing Instructions are available latest Wednesday August 11th, 2010 15:00 in the race office.
- Participation:** The regatta is open to boats from other countries.
ISAF Regulation 19 and Swiss Sailing Regulation of application
Competitors must be members of a Club affiliated to ISAF. For Swiss competitors the amendments of Swiss Sailing to the Eligibility Code will apply.
- Races:** A maximum of 12 races are sailed. For 4/8/12 races 1/2/3 discards. No more than 4 races per day. The Low Point Scoring System of Appendix A will apply. To constitute the International Swiss Championship at least 4 valid races must be sailed during the scheduled time.
- Course:** As defined by the Sailing Instructions
- Advertising:** - Competitor advertising is permitted.
- Advertising of the main sponsor of the event is provided on the boats (ISAF advertising code, R.20.4)
- Inscription:** By June 30th, 2010 – Late entry until Wednesday August 11th, 2010 19:00 Uhr.
Following documents must be attached to the completely filled entry form:
- Measurement Certificate or Certificate of Conformity
 - Confirmation of club membership or Licence
 - Confirmation of the legitimacy for advertising Category C
 - Confirmation of the third-party liability insurance.
- Entry Fee:** CHF 280.-- / CHF 200.— (Juniors until completed age of 21)
Late entry fee CHF 70.--
The entry fee includes 3 dinners (Th./Fr./Sa.) without drinks
For accompanying people additional dinners could be ordered.

- Private support boats:** Private support boats must be registered latest until August 11th, 2010 at the race office. Motorboats need official permission (Vignette) for Lake Aegeri. They can be ordered with SCAe latest by 31.7.2010. Afterwards permission must be organized individually. Instructions of the organization and race committee must be followed. Private support boats will be integrated in the safety arrangement of the Championship.
